## **ABOUT THE THEME:**

#### "CRIMINOLOGY AND CRIMINAL JUSTICE REFORMS"

When the world was fighting the pandemic a shadow pandemic in the nature of the increase in crime rates and evolution of criminal activities from real to virtual world wreaked havoc in the living conditions of the world. The pandemic not only led to an increase in the crime rates in the world but has highlighted and widened the existing gaps in the criminal justice system. To build ourselves better from the crime that the pandemic caused, the criminal justice system needs to be reformed and visualized again beginning with the acknowledging of the existing gaps in the justice system of the country and to having the ability to revive the existing justice system of the country. Today, the understanding of the crimes per se is not sufficient, but it needs to be understood and

researched with the holistic view with other interconnected disciplines. For the system that our country provides today needs to be thought of again, to acknowledge the gaps in the system and to create a counter approach for the evolving crime in the world. This colloquium aims to understand the nuances of the criminal justice system at the intersection of law and criminology.

The discourse spread across two days will be evaluating vital aspects of crime and criminology. The discourse not only focuses on crime especially against women and children but intends to discuss the solution-based approach towards achieving the goals of the criminal justice system with not just prevention of crime but having a reformative rehabilitative approach towards offenders as well. These are the important aspects of crime against women and children while understanding the factors burgeoning these crimes. The colloquium closely analyses the role of developing systems of crime mapping and crime control at the interplay of socio-legal and technological aspects, to identify as well as prevent crime. With the development of cybercrimes, the state and their counter-attacks, need to inculcate technological advancements to be one step ahead of cybercrimes. The discourse will focus on the interplay of reformative and preventative approaches to counter cybercrimes. The dialogue will also examine the great importance of forensic evidence and the forensic justice system. The analysis focuses on the value of forensic evidence in making the process of investigation efficient and accountable.

During the course of the colloquium, the esteemed speakers and participants will vary their focus on the interplay of the changing view of the criminal justice system spread across different disciplines, to study the importance of developing forensic science in the crime handling, how justice can be delivered with better technological advancements and studies focused on psychological impact of the criminals and the victims.
