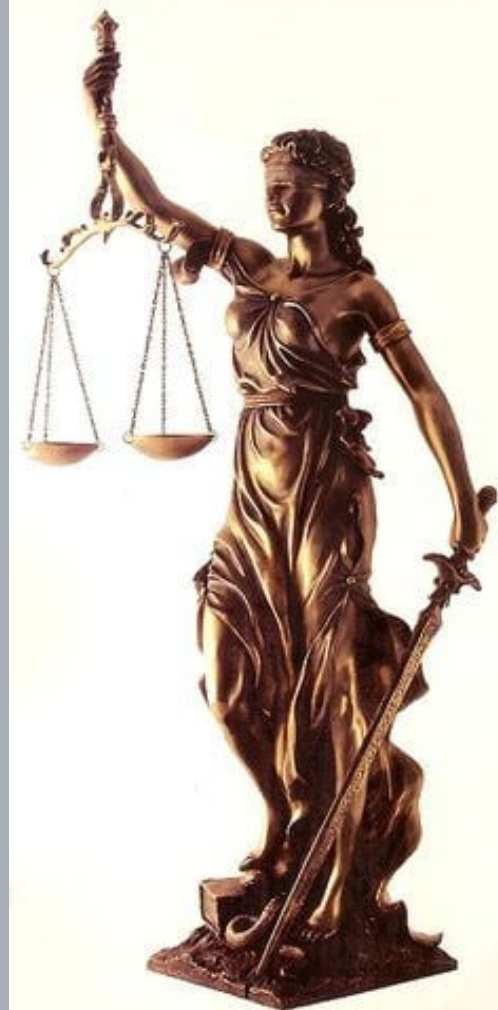


ABOUT THE PROGRAMME

Victims of crime play an important role in the criminal justice system as they provide an eyewitness account of the incident of crime and are relied upon heavily by the prosecution and the Court in order to adjudicate the case and decide the guilt/innocence of the accused. However, the criminal justice system has developed in such a way that more emphasis has been laid on the rights of the accused and the victim's rights/ role is being pushed to the periphery.

In recent years, a "victim's rights movement" has developed to curb this inequitable trend. The movement began as a coalition of various organizations seeking to redress the criminal justice system's inadequate treatment of victims. This Seminar, aims to bring forth varied ideas and pedagogies used across the globe towards uplifting the Victims.
