NATIONAL LAW UNIVERSITY DELHI & NATIONAL ACADEMY OF LAW TEACHERS PRESENT ADVANCED COURSE IN CRIMINAL LAW (02 MAY – 07 MAY 2022)

UPDATED: CALL FOR APPLICATIONS

Background

The National Law University Delhi is among India's leading law universities, ranked second in the National Institutional Ranking Framework for the last two years. The University offers a five-year integrated B.A.LL.B. (Hons.) and one year LL.M. program, along with diplomas, certificate courses and professional programs for both legal and non-legal professionals.

The University has made tremendous contributions in public discourse on law through research and pedagogy. As a leading institution of higher learning in India, the University continuously strives to adopt interdisciplinary approaches as part of its commitment towards high quality education and research. This is evidenced in the mandate of its specialised research centres and the diverse work undertaken by its faculty. Over the last decade, the University has established many research centres such as the Centre for Communication Governance, Centre for Innovation, Intellectual Property and Competition, Centre for Corporate Law and Governance, Centre for Criminology and Victimology, and Project 39A. And through its faculty, the University has made submissions, recommendations, and worked in advisory/consultant capacities with government entities, universities in India and abroad, think tanks, private sector organisations, and international organisations.

National Academy of Law Teachers

In 2011, National Law University Delhi established the National Academy of Law Teachers with the objective of promoting and protecting teaching-learning methodology by training teachers in advanced curriculum development and teaching methods. It has organised training workshops, orientations and capacity building programs on themes across law and social sciences.

About the Course

The National Academy of Law Teachers under the aegis of National Law University Delhi invites applications from eligible candidates for an *offline*, *in-person* 'Advanced Course in Criminal Law' from 02 May to 07 May 2022 at National Law University Delhi's campus.

The course is designed to offer an advanced inquiry into criminal law, on themes which are scarcely included in regular curriculum and teaching-learning process. These include aspects of history and evolution of criminal law, essential principles of criminal liability, processual justice and critiques of the formal criminal law system. These sessions will also involve reflection of criminal law's engagement with gender and discussions about contemporary

criminal law reforms. The course will equip participants with a nuanced understanding of criminal law jurisprudence and enable them to enrich their pedagogical approach in the classroom.

Details of the Course

<u>Eligibility</u> - Teachers/Instructors from India and South Asia with a minimum of **two years of experience** in teaching criminal law are invited to apply.

<u>Seats Available</u> – A total number of **40** participants will be accepted into the course. Applications will strictly be accepted on a **first-come**, **first-serve basis**.

<u>Duration & Course Structure</u> – The Course will be held over 6 days (02 May – 07 May 2022), with a total of 24 sessions over approximately 8 hours each day.

As per the thematic agenda, sessions will be held as lectures, group exercises and activities, as well as discussions. Participants will be given ample opportunity to engage and interact with course instructors and their fellow participants, to enable an environment of collaborative learning and teaching.

Course Instructors - The course will be spearheaded by Professor B.B. Pande, Distinguished Professor at National Law University Delhi. He is affiliated to institutes of national and international repute in various capacities such as Lecturer, Faculty of Law, University of Jabalpur, Jabalpur (1962-70); Senior Lecturer, Faculty of Law, University of Dar- es- Salaam, Tanzania, (Africa) (1981-83); Professor of Law, Lucknow University (1991-1994); Professor of Law, Campus Law Centre, Faculty of Law, University of Delhi (India), till superannuation in 2005 and Human Rights Chair Professorship of the National Human Rights Commission, New Delhi (2007-2008). He is widely recognised for his scholarship in criminal law and has recently released his book, Criminal Law and Criminal Justice: Advanced Legal Writings.

The sessions will also be enriched by the contribution of lecturers from NLU Delhi's core faculty, as well as external experts from litigation, research and academia.

<u>Certificate</u> – All participants will be awarded with a certificate upon successful completion of the course.

<u>Course Fee</u> - The course registration fee is Rs. 3,500/-. Accommodation will be provided on 'first-come, first-serve basis' depending upon availability. It should be noted that accommodation will only be provided on a twin-sharing basis, and will not be provided to participants residing in Delhi.

Please note: For candidates who have already registered, the university will process the difference upon the commencement of the course.

Participants are requested to not make any travel arrangements until the organizers of the course confirm their registration within 12-24 hours of their payment of the course fee. If your participation is not confirmed, you will be informed and the course fee will be refunded in full.

<u>Last Date</u> - The last date to apply for the course has been extended to **30 April 2022 (23:59 PM IST).** Applications received after this date and time will not be accepted.

Conditions

- The course will be conducted offline and in-person on National Law University Delhi premises. No requests for virtual participation in the course will be allowed.
- The application process is online, no physical applications sent by post will be accepted.
- Due to the limited number of seats and admission on a first-come first-serve basis, interested participants are requested to register at the earliest.
- Only participants residing out of Delhi/ NCR are requested to apply for accommodation.
- The participants will be accommodated at the University guesthouse and will be required to abide by the applicable rules.
- Participants will be expected to strictly follow COVID-19 protocols during the course and while on the University premises.
- Participants travelling from outside Delhi are also expected to adhere to international and local regulations on COVID appropriate behaviour before travel and while present in Delhi, to ensure that the course can be conducted smoothly without any health-related concerns.
